Accidental Release

Handling

Handling and Storage Precautions: COMBUSTIBLE, VERY SLIPPERY ON FLOORS. AVOID EXCESSIVE HEAT. DO NOT STORE NEAR AMINES. IF DUST/MOLTEN, WEAR MECHANICAL RESPIRATOR & PROTECTIVE CLOTHING. Other Precautions: HANDLE AS WITH WAXES IN GENERAL. AVOID BREATHING FUMES FROM MOLTEN MATERIAL. WATER STREAM ON MOLTEN BURNING MATERIAL MAY SCATTER AND SPREAD FIRE.
