Fire Fighting Procedures: SELF CONTAINED BREATHING APPARATUS WITH FULL FACEPIECE IN PRESSURE DEMAND; FULL BODY PROTECTIVE CLOTHING. Unusual Fire/Explosion Hazard: CAN REACT WITH METALS TO LIBERATE HYDROGEN, A FLAMMABLE GAS.

Accidental Release

Spill Release Procedures: SPILL RESPONSE SMALL SPILL/NEUTRALIZE WITH BAKING SODA OR SODIUM CARBONATE. LARGE SPILLS: DIKE AREA, PUMP TO SALVAGE TANK OR CONTAINERS.

Neutralizing Agent: SEE ABOVE.

Exposure Controls

Respiratory Protection: NONE IN NORMAL USE.
